

LEGAL TERMS AND CONDITIONS

1. Purpose

The Istituto Europeo di Design, SL, with CIF B80813959, is scheduled to hold a contest on Instagram (Competition entitled #LiveFromIEDSummerSchool) that will reward the three most creative photos with scholarships for courses at the IED Madrid.

The first winner will be awarded a full scholarship for one of the Summer Courses at the IED Summer School, to be held in July 2017.

The second winner will be awarded a grant of 50% of the course fee of one of the graduate courses of IED Master 2016/2017.

The third winner will be awarded a grant of 50% of the course fee for one of the Summer Courses at the ID Summer School, in July 2017.

2. Eligibility

To participate in the contest, it is necessary to upload to Instagram, with the hashtag #livefromiedsummerschool, photographs taken during classes, visits and activities of the summer course in which the student is enrolled and tag the @iedsummerschoolmadrid Instagram profile.

Each participant may participate with an unlimited number of photographs provided they use the #livefromiedsummerschool hashtag and tag @iedsummerschoolmadrid. Photos without the hashtag or tag will be disqualified.

3. Prize for the Contest "Live from IED Summer School".

Participants who publish the photographs taken during the summer courses with the hashtag #livefromiedsummerschool and tag @iedsummerschoolmadrid, no later than July 28, 2016 at 23:00 (Madrid time), will participate in the competition "Live from IED Summer School".

The most creative photograph, according to the jury, will win a full scholarship to one of the Summer Courses at the IED Summer School to be held in July 2017.

For the selection of the winning photograph originality, talent and a reflection on the creative spirit of the IED Madrid will be considered.

The jury will also choose a second and third winner.

The second prize will be a grant of 50% of the course fee of one of the graduate courses of the IED Master and the third prize will be a grant of 50% of the course fee on one of the Summer Courses of the IED Summer School in July 2017.

The second and third winners will have to pay the registration fee and 50% of the chosen course fee on the date set by the IED.

Prizes are not exchangeable or refundable in cash.

The winners will have to choose a course and accept and sign the General Student Regulations for contests-winners and scholarship-holders, available to students at our headquarters.

Scholarships are only valid for summer courses in July 2017 and graduate courses to be held in October 2016 and March 2017.

The winners of the contest must attend at least 90% of classes to keep the scholarships and obtain the final diploma. If they fail to attend 90% of classes, the winners will have to pay the full amount of the course fee.

All courses require a minimum number of students to be carried out. In the case of not reaching the minimum number of students enrolled, the winners may not benefit from the chosen course and will have the option to choose from one of the other courses available. All courses have limited places. If the maximum number of students is reached, the winners may not benefit from the chosen course and will have the option to choose from one of the other courses available.

4. Contest Dates

The promotional campaign for the contest, in which you can upload your photos to Instagram, begins the first day of the summer course in which you are enrolled and will end on July 28, 2016 at 23:00h (Madrid time), the deadline to upload your pictures. The winners will be announced on July 29, 2016 at 20:00h (Madrid time) during the delivery of diplomas of the Summer Courses and will be published on the summerschool.iedmadrid.com website at 21:3. The winning photograph will become the property of the IED Madrid.

5. Winners

Three scholarships will be awarded and there will be a first winner, a second winner and a third winner.

6. Jury

The winner, the second and third classified will be selected by a jury.

The jury for "Live from IED Summer School" which will select the winner and the second and third places will consist of:

7. Acceptance of rules

Failure to meet any of the requirements of the terms and conditions will result in the exclusion of the participant from this contest.

It also reserves the right to change the terms of the promotion or to cancel it, should there be just cause, and promises to communicate with sufficient notice the new legal terms or cancellation.
